Sir/Madam,

You may be aware that the Central Sanskrit University (CSU), Delhi is the biggest multi Campus Central University across the country, established by an Act of Parliament. The CSU is being implemented various Central Schemes of Ministry of Education, Government of India for Sanskrit Promotion in the country. In this context, the CSU has invited the applications under the Ashtaadashi (18 Projects) Scheme from the Universities/Educational Institutions/Organizations/NGOs etc. vide this university's notification dated 07.11.2022 for financial assistance in the year 2022-23.

Further, the Competent Authority has constituted an Expert Committee to examine the proposals, received from various institutions & agencies. Based on the submitted proposal (s) and after an interface meeting with the concerned P.I./Co-P.I., the Committee submitted its recommendations to GIAC. The recommendations were considered and approved by the GIAC in its 33rd meeting held on 14.03.2023.

Now, therefore, I am directed to convey the tentative approval/sanction of the Competent Authority for Grant-in-Aid under Ashtaadashi Scheme (18 Projects) for conducting the project is as follows:-

It is further informed that Guidelines of the Scheme of Ashtaadashi – Eighteen Projects for sustaining the growth of Sanskrit and the list of projects recommended by the Expert Committee under Ashtaadashi are available at University's website under Schemes portal (<https://www.sanskrit.nic.in/schemes/ashtaadashi.php>).

Accordingly, you may kindly direct the concerned P.I./Co-P.I. of your institution that go through the recommendations/suggestions of the Expert Committee & approved grants, which details are available in the website of the CSU, and **make necessary modifications as per recommendations and discussions held with the Expert Committee in the proposal & budgetary provisions etc., and re-submit the proposal in prescribed attached proforma to the CSU through email i.e. ashtadashi@csu.co.in, latest by 22.03.2023.** You may also have requested to send the same through postal, latest by 30.03.2023.

The 50% or 75% of the sanctioned Grants-In-Aid i.e. Rs.600000/- (Six lakh only) will be released to you as first instalment after the receipt of required documents. The balance amount will be released as per clause Ashtaadashi No. 13 of guidelines & after completion of the 1st phase of the Project.

Consequently, if the Principal Investigator of the Project is willing to do the project within the sanctioned budget then declaration for acceptance is to be submitted to CSU, in prescribed proforma (Form No. Ashtaadashi - II) attached herewith.

Accordingly, the Head of Institution/Organization will have to submit the following:-

- a. Revised project proposal alongwith statement of expenditure in form no. I of Ashtaadashi scheme, as per recommendations and discussions held with the Expert Committee.
- b. Declaration for acceptance in form no -2 Ashtaadashi scheme.
- c. The pre-receipt for **Rs.1200000/- (Twelve lakh only)**, duly signed bond paper (for NGOs/Voluntary Organizations)/Undertaking (for Government/Autonomous Institutions). The prescribed format is available in University's website (<https://www.sanskrit.nic.in/schemes/ashtaadashi.php>).
- d. The bank account details such as: -
 1. Name of the account holder (Institution)
 2. Name of the Bank
 3. Account number
 4. IFSC Code
 5. PAN/TIN number
- e. For NGOs/Voluntary Organizations – The NGOs must, invariably, be registered with the Darpan Portal of NITI Ayog, Govt. of India and submit the same.
- f. Audited reports of last three years (if not submitted earlier) see the format Ashtaadashi guidelines No.13).

The above documents with due recommendations of the Head of Institution shall be submitted to CSU, latest by 22.03.2023 through mail, failing which this tentatively sanctioned project stands cancelled. Final sanction letter of the project will be issued after receipt of the above documents.

All the projects sanctioned should be reviewed periodically. The review is done after every six months. Funding for publication of the work need not be committed while the project is being sanctioned. The decision can be taken after peer-reviewing the work that is submitted by the investigators through proper channel to the University.

The audited statement of accounts/expenditure, utilization certificate for the sanctioned amount, duly certified by the Chartered Accountant (in original), detailed report on project (soft & hard) copy etc. will have to submit after completion of the first phase/six month of the project in the prescribed proforma (Form No. Ashtaadashi – VI/VII), failing which, further grants cannot be released. For more details, see guidelines of the Ashtaadashi scheme at CSU website–under Schemes.
